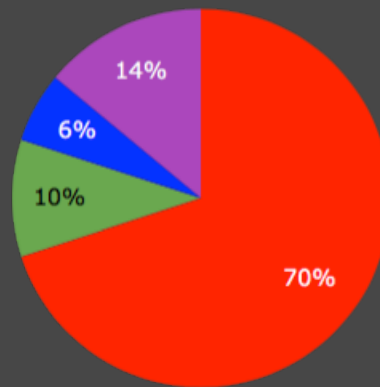
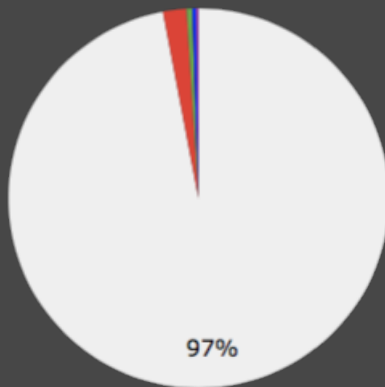

## Easy integration

## Presence of targeting

sites, which installed the buttons, can select the right audience to pay for multisharing



## Protection from cheating

the system includes mechanism of protection against bots, which limits the amount and size of paid multisharing

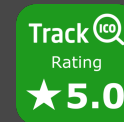
